



**CANVASSING OF RETURNS
REGULAR MUNICIPAL ELECTION
MARCH 2, 2010**

The Canvassing Board was called to order in the City Commission Chambers at 3:04 p.m., March 4, 2010, with Clerk-Treasurer Michael Anne Lannon and Magistrate Judge Warren Walton in attendance. Seven members of the public were present: Todd Wildermuth, Margaret Ann Mattorano, Lorenzo Flores, Scott Weese, Jesse Johnson, Sharon Neideman and Sandra Mantz. After canvassing, abstracting, and otherwise ascertaining that 1,039 votes were cast of the 4,072 registered voters, in the March 2, 2010 Regular Municipal Election, the Canvassing Board certified the Election Results as indicated on the attached certificate of canvass.

Done at the City of Raton, New Mexico this 4th day of March, 2010 in the office of the City Clerk.

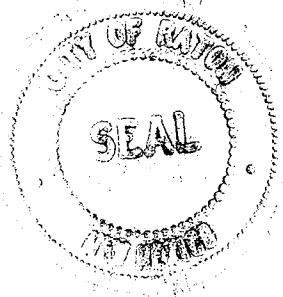
